
Prof. D. Panduranga Rao

DISTINGUISHED SPEAKERS

His Excellency Mr. Graeme Charles Waters, High Commissioner of New Zealand.



His Excellency Mr. Graeme Charles Waters, High commissioner of New Zealand speaking at XIME His Excellency H.E Graeme Charles Waters, High Commissioner of New Zealand visited XIME in July. Describing himself as a great fan of India and its culture, he thanked the institute for the warm welcome he received and the opportunity to talk about "The Role of New Zealand in International Business".

He said that New Zealand had come a long way since its days of economic upheavals. Its relationship with India had grown manifold over the last few years as a setting, be it for Bollywood Films or for strategic training partnerships. He talked about the Business model shared between India and New Zealand with special reference to the presence of niche companies in the IT sector. India's contribution to New Zealand had mainly been in the field of diamonds, garments and seasonal agricultural outsourcing. Quoting the recent changes in the educational field institutions in New Zealand, he said that the Indian institutes were now looking at actively developing a symbiotic relationship with various universities in New Zealand in terms of students and faculty exchanges. Describing New Zealand as a 'nice package', he highlighted the plethora of opportunities in higher studies that the country offered. He also mentioned that New Zealand had developed expertise in core areas such as e-banking and software development which offer immense scope for employment.

The talk certainly provided a deeper insight into New Zealand's economy and its tremendous growth over the last couple of years. New Zealand's immense growth in the field of educa-

tion and tie ups with various Indian institutes should provide a platform for the students to consider New Zealand as a potential destination for higher studies. Dr. Jagdish .N. Sheth, renowned "Marketing Guru", was in XIME to address the students on "How India will get globally integrated?"

Predicting that India will emerge as a global power in post 2025 era, he summarized the various forces driving this shift into economic pragmatism, collapse of communism and the globalization of the world. Dr. Seth observed that there is a major repositioning of economies from domestically isolated economies and socialistic government policies to globally integrated economies and competitive market structure. He called for the need of more and more global mergers and acquisitions for the development of the our economy. Creating global brand equity, enhancing productivity

through infrastructure development and investing in design and research were the other key points suggested by him to enable India to be globally integrated. He observed that by investing in education India can definitely move up the knowledge ladder. In his opinion, India's future will depend on the geo political realignment of nations and emergence of New Triad Power that compromises India, China and USA. He reiterated the importance of becoming globally integrated, investing in quality reputation design and research and concluded on the positive note that India is destined to become a major economic power in the 21st century.

A question and answer session followed the talk, stimulating a good discussion about the prevailing issues concerning Asian countries and their economy.

Mr. Seby Chacko, addressing the students at XIME, emphasised on the importance of a HR professional being proactive and self driven in spite of HR being a thankless job. An alumnus of XLRI, Mr. Seby Chacko was involved in wide off-shoring and outsourcing as Regional Director of Citibank- wherein he implemented the huge task of outsourcing to global players like Infosys, I-flex, E-serve Etc. Speaking of Reuters, where he now heads the HR dept for South Asia region, he said that Reuters was an organization with a 150-yr old rich history and has integrity written all over it. He also pointed out few factors that differentiated an Indian MBA graduate from that of a foreign MBA interms of the work experience level among the students and the industry exposure that they get, while in the college.

Finally, he advised the students on how they can be effective & successful HR professionals. He reiterated the importance of being business-focused; getting operations right before getting strategies right; importance of learning necessary technologies like SAP, PeopleSoft; updating oneself with HR news to get a universal as well as a microscopic perspective of HR and finally moving ahead with an optimistic attitude.
