


# 1. SIP SUNDAYS- EPISODE 3


# 2. FINTALKS


# 3. CLUB ORIENTATION CEREMONY: LINKUP

From the 15 initial participants, 6 advanced to Round 2: Pitch Perfect, where each participant presented a 2-slide analysis of a company dataset in just seven minutes. The top 3 among them then faced the ultimate test. Round 3: The 'Best Financial Manager', a high-pressure stress interview focused on composure, confidence, and critical thinking.

Naini Luniya from Batch 30, Section -C was crowned the Best Financial Manager with her consistent performance and unwavering determination. Finalists Ayushi Mishra and Abhikant Thakur also showed remarkable insight and skill, making the competition fierce and unforgettable.

#### 14.DECODING UNION BUDGET 2025

On February 14, 2025, Finitiative, in collaboration with the Management of XIME Bangalore, organized a panel discussion titled Decoding Union Budget 2025. This insightful session brought together industry experts to analys the financial implications of the recently announced Union Budget.



Dr. J. Philip, Chairman of XIME Bangalore, delivered the inaugural address, commending the budget's bold initiatives. He highlighted key measures such as the revised ₹12.75 lakh taxable income threshold and India's competitive 30% tax rate compared to global taxation standards.

The session was moderated by CA Rakesh Arakere, focused on the evolving role of the Union Budget, emphasizing long-term stability over short-term individual impacts. The discussion revolved around economic viewpoints addressing macroeconomic and microeconomic aspects, sectoral impact examining industry-specific

implications, changes in taxation outlining the revised tax structures and employment & job trends that can and will lead to demographic shifts and employment reforms.

Dr. Krishna Raj emphasized fiscal deficit concerns, high interest rates, and economic growth priorities such as agriculture, employment generation, and regional balance. Whereas CA Abraham Cherian provided insights on taxation changes, urban development, and key policies impacting industries like



FMCG, EV battery manufacturing, aviation, and fisheries. CA Krishnanath N discussed the increase in the income tax exemption limit, the moderator CA Rakesh Arakere addressed key reforms such as the Internship Scheme 2024, which incorporates a 90-hour work week to promote skill development and employment readiness.



This session helped simplify complex ideas and showed how they connect to jobs, growth, and daily life. By learning more about these financial changes, we can make better decisions and stay informed about India's economic future. Let's keep asking questions and exploring new ideas.



# 15. HOPSTOCK AT XIMERA

On February 27th and 28th 2025, the Xavier Institute of Management and Entrepreneurship, Bangalore, hosted its flagship XIMERA Fest, bringing together some of the brightest minds in finance. Among the many exciting events, Hopstock, organized by Finitiative XIME, stood out with its intense, high-stakes financial simulation that challenged participants' strategic thinking and decision-making under pressure.



The competition revolved around a series of challenges designed to reflect real-world financial scenarios where teams had to do play different rounds like Crisis Analysis & Turnaround where they had to analyse struggling companies, identifying solutions to restore stability, followed by Mergers & Acquisitions round where the participants assumed the role of investment bankers, structuring acquisition strategies to maximize value.





The Investor Puzzle Challenge involved solving complex riddles that blended logic with financial concepts tested participants' mental agility followed by the Fraud Detection round where teams investigated financial discrepancies, applying forensic skills to identify potential risks. In the final show round, the participants were engaged in a fast-paced trading environment with Real-Time Trading Simulation to check their portfolio management and strategic decision-making skills in fluctuating market conditions.
